HS State Finals Rodeo Report:

Jay and Tater met with Bob & Jan Parker, owners of Majestic Valley Arena, about holding the 2024 HS Finals at their facility.

- Majestic Valley will charge a flat fee for the use of the facility, and they will take care of camping and stalling.
- The stall barn has 164 stalls
- 142 portable stalls
- 10 acres for dry camping
- MHSRA can have food vendors and other vendors come in
- There is a big screen available to use, this would be a separate charge from facility use
- They have ticket takers available that we can hire to take rodeo tickets
- There are rooms available for scholarship interviews, office, prom, etc.

Much discussion was held about the facility. There would be some additional fees such as porta potties, possible Cowboy Channel Coverage, , tractor, etc..

Lewistown has reached out to us about hosting the state finals as well. They would charge \$2000/day which includes a tractor and driver. MHSRA would be responsible for all camping, stalls, tickets, etc.

Discussion was held about the two available facilities to host the state finals.
